Ms. Pottinger and Mr. Clouse met with the claim adjuster from Enduris onsite January 30 to go over invoices incurred from the recent event. Ms. Pottinger informed the Board that Enduris also covered the registration fees for the WASWD Commissioners Workshop held January 31.

Ms. Pottinger reported that the signatures gathered for the annexation in the Ridgecrest neighborhood have been submitted to King County Elections for certification.

The Lake Forest Park Planning Commission will be presenting the utilities portion of the Draft Comprehensive Plan at the February 17 meeting.

SnoKing has been served with a 3-day Pay or Vacate order. To date, the District nor Short Cressman and Burgess have received a response or payment.

As part of her work on the Public Works Board, Ms. Pottinger reported that there is a bill being introduced in the House of Representatives to add four legislators members to the Public Works Board.
