APPROVAL OF MINUTES

Commissioner Schoonmaker made a motion to approve the minutes of the April 7, 2015 Regular Meeting. Commissioner Ricker seconded the motion, which then passed unanimously. The Board signed the approved minutes.

APPROVAL OF VOUCHERS

Commissioner Schoonmaker made a motion to approve vouchers 111560-111602 and voucher numbers 3791-3807 in the amount of \$281,681.48 from the maintenance fund and voucher 00042-00048 from the construction fund in the amount of \$11,719.60. Commissioner Ricker seconded the motion, which then passed unanimously. The Board signed the vouchers.

NEW / OLD BUSINESS

Resolution 2015.04.07: Determining that certain territory referred to as Ridgecrest Annexation 14-1 be Annexed to the District. This Resolution was presented, discussed, moved by Commissioner Ricker, seconded by Commissioner Schoonmaker, and approved unanimously by the Board.

MANAGER'S REPORT

Ms. Curry talked about the special events the District will be participating in through the summer.

Mr. Clouse reported that the pre-construction meeting for the North City Pump Station project has been scheduled for Thursday, May 7 at 8am–11am in the District Board Room.

He discussed the status of the City of Lake Forest Park's NE 178th Street project.

Mr. Clouse gave an update on the status of the recent work done on the vactor truck.

Ms. Pottinger reported that the Assumption Bill passed in the Senate by a vote of 43-6. Under this bill, assumptions will now be subject to referendum if voters in the area to be assumed file a qualifying petition after a city initiates the assumption process. This bill would go into effect 90 days after being signed by the governor.

Ms. Pottinger gave an overview of the Lake Forest Park Water District's Wellhead Protection meeting.

Ms. Pottinger reviewed the MRSC Roster options and the staff's decision not to renew the roster at this time.

She also spoke about the District's upcoming meetings and events:
