Ms. Shosten gave an update on the annual audit. She encouraged the Commissioners to attend the exit conference.

Ms. Pottinger announced that North City Water District will host the February 9 WASWD Section 4 meeting.

Ms. Pottinger gave an update on the past due account status of the Sno-King lease.

Ms. Pottinger is waiting to hear back from Lake Forest Park Water District on the draft agreement regarding services to various properties along the corporate boundaries between both districts.
