

MINUTES OF SPECIAL MEETING OF THE BOARD OF COMMISSIONERS

The special meeting was called to order by Board President Ricker at 2:00 p.m. on February 14, 2019 at the North City Water District Board room. The Board President previously called for a special meeting on Tuesday, February 12 at 1:00 pm but that meeting was cancelled due to inclement weather. The Board President then called a special meeting of the Board for today at 2:00 p.m. The purpose of the meeting was for the opening of bids for the Phase II Maintenance Building project.

PHASE II - MAINTENANCE BUILDING BID OPENING

Operations Manager Denny Clouse declared the bid acceptance closed at 2:01 p.m. Three bids were received. Mr. Clouse briefly explained the bid opening process. The District has a budget of \$5,000,000 for this project inclusive of sales tax. Mr. Clouse explained each bid would be opened and the full buildout price from line #41 of the bid form included in Addendum 1 will be read. If any of the bids fall below \$4,500.000 the apparent low bidder will be announced. If no bid is below this amount, bid alternatives will be subtracted starting with alternative #4 (Wash Building) and continuing with alternatives #3, #2, and #1 until a bid of less than \$4,500,000 is reached. At the point a bid of \$4,5000,000 is obtained, the apparent low bidder will be announced. Bidders will then have one hour to submit a complete list of subcontractors. Apparent low-bid will be certified by Wagnar Architects.

Mr. Clouse opened each bid and the total bid amount was recorded. All bid amounts for the full buildout exceeded the \$4,500,000 amount. No apparent low bid was announced. Therefore, Alternative #4 (Wash Building) was subtracted from the full bids. The amount of Alternative #4 was announced for each bid and subtracted from the full bid amount. Following this calculation, the apparent low bid was identified as JH Kelly with the bid amount of \$4,046,347. Bidders were given until 3:05 p.m. to submit subcontractor lists. Copies of the bid were given to Wagnar Architects to begin the certification process.

The meeting was adjourned at 2:14 p.m.
