ABOUT THE AUDIT

This report contains the results of our independent accountability audit of the Shoreline Water District from January 1, 2011 through December 31, 2012.

We evaluated internal controls and performed audit procedures on the activities of the District. We also determined whether the District complied with state laws and regulations and its own policies and procedures.

In keeping with general auditing practices, we do not examine every transaction, activity or area. Instead, the areas examined were those representing the highest risk of noncompliance, misappropriation or misuse. The following areas were examined during this audit period:

- Financial condition
- Utility billing rate changes

- Public works procurement
- General disbursements

RESULTS

In the areas we examined, the District's internal controls were adequate to safeguard public assets. The District also complied with state laws and regulations and its own policies and procedures in the areas we examined.

ABOUT THE DISTRICT

The Shoreline Water District is located in the northern part of King County and has approximately 8,200 connections from the Snohomish County line to the city of Seattle and from approximately Interstate 5 east to Lake Washington. The District maintains 92 miles of mains, two reservoirs, 700 hydrants, three supply stations, two booster stations and one pump station.

An elected, three-member Board of Commissioners governs the District. The Board appoints a District Manager to oversee the District's daily operations as well as its 13 employees. The District derives most of its operating revenue from the sale of water. Other nonoperating revenue includes administrative fees and charges. For fiscal years 2011 and 2012, the District operated on an annual budget of approximately \$4.6 million and \$5.3 million, respectively.
