

## Low Income Reduced Water Rate Program

North City Water District is offering a rate reduction to eligible low-income persons. For qualifying applicants, the bi-monthly Fixed Charge Single Family 5/8" x 3/4" will be reduced by 50%, regardless of meter size.

For example, the current Fixed Base Charge Single Family 5/8" x 3/4" would be reduced from \$60.22 to \$30.11 on each bi-monthly billing. Actual water usage will continue to be billed at the regular step rate amount.

## Qualifications

1. Applicant must be the person responsible for payment of the water charges, (if you are a Tenant, the account must have a signed "Landlord/Tenant Agreement" between the owner and North City Water District.
2. Applicants must reside where the low-income rate is being requested.
3. The applicant's residence must have a separate individual water meter.
4. Applicants must sign an application form under penalty of perjury accompanied by appropriate documentation.
5. Applicant's combined household adjusted gross income from all sources, excluding children under eighteen, for the previous year (2024) did not exceed the dollar amount listed below based on the size of the household.
