About The Position

This position entails regular and recurring installation, repair, and maintenance work in the District's water systems. The successful candidate will play a key role as a member of the Field Crew. Specific duties include but are not limited to...

- Installs, services, and repairs all District water facilities and system components including water mains, fittings, valves, fire hydrants and meters.
- Able to operate a variety of mechanical equipment driven by air, hydraulics, and electricity, and heavy equipment including dump trucks, service trucks, jack hammers and back hoes, etc.
- Taps water for connections; repairs street curbs, streets, and sidewalks impacted by operations.
- Locates, inspects, and performs necessary repairs on new and existing water services and components.
- Ensures on-site safety compliance during field operations.
- Reads water meters; assists staff in meter re-reads; checks for indications of leaks and advises customers accordingly.
- Works with other District staff to perform service disconnection, water meter lock outs, and reconnections.
- After an initial trial period, responds to emergency call outs and after-hours support.

Minimum Qualifications *(see our website for full details)*

- Required: High School Diploma or GED.
- Required: Ability to obtain a Water Distribution 1 or 2 within one year of appointment.
- Required: Valid Washington state driver's license; acceptable driving record; a Commercial Driver's License (Class "A" with Airbrake and Tanker Endorsement) is preferred, or the Employee must obtain a valid CDL within 12 months of hire.
- Required: Ability to attain Certified Competent Person; Industrial First Aid Card CPR/Blood Borne Pathogens; Certified Work Zone Traffic Control (Flagging Card) within one year from date of hire.
- Preferred: one year of experience in the maintenance, repair, and operation of a public utility, or water district.
- Any equivalent combination of education and experience that provides the applicant with the knowledge, skills, and abilities required to perform the job.
