When Bob says the water industry has changed, he's speaking from experience. His first job with the District was reading water meters on-site, which is now done remotely in the office, thanks to our electronic water meters. Smart phones have eliminated paper maps and pagers, "heck we've even changed the way we dig holes," said Bob, "rather than a backhoe, we have a giant 'vacuum on wheels' that allows us to dig smaller holes that are much safer around other utilities." Another improvement set up by Bob enabled backflow tests to be submitted electronically and tracked with software—saving time and money for the District. "Even though our industry has changed quite a bit in 35 years, our mission remains the same," he said proudly, "to provide safe, clean drinking water and adequate fire flow to put out fires when needed."

After 35 years, Mike's extensive knowledge of our water system was instrumental during all of the research and coordination for the District's lead service line inventory in 2024. That same level of knowledge is currently being put to excellent use in upgrading our Geographic Information System (GIS) mapping technology—which will save time and money on countless operational tasks. Mike echoed Bob regarding the constant state of change in the industry, even though many of the changes aren't noticeable to customers. "All the growth in our area requires ongoing system upgrades," he attested, "yet the majority of these upgrades are underground, out of sight, and out of mind." Thankfully, Special Purpose Water Districts, the state Department of Health, cities, engineers, laboratories, and countless others are all working together behind the scenes every day to ensure we have clean water today and into the future.

### How we ensure optimum circulation, fire flow, and water quality

North City Water District has been incredibly busy with a number of developer-funded projects to expand and enhance your water system infrastructure. In fact there are so many projects, either underway, awaiting final paperwork, or recently completed, that it deserved its own full spread in this newsletter.

In some of these projects, our water mains were already upsized to improve water circulation, enhance quality, and/or create system redundancy, so the developer was simply able to connect to our existing water system after paying the connection charge. In other cases, the developer was required to make improvements to the existing water system in order to ensure adequate fire flow capacity for their new development.

Projects marked "physically complete" are finished, but need final paperwork submitted before we can officially close out their development. All other projects are either ongoing or have been completed in the last two years.



As with all of our projects, if water service to a residence or business will be impacted for any duration during construction, we will notify them several days in advance with an estimated time they'll be without water.
